### **Immigration Reform**

There is an ever narrowing window for Congress to pass fair immigration reform prior to the mid term elections. Senators Schumer (D-NY) and Graham (R-SC) continue to work on the content of legislation. The latest word is that they have settled on a national biometric identification card that all American workers would eventually be required to obtain. Little progress has been made since last fall on immigration reform and advocates, who have become increasingly frustrated with the lack of action, have called for a major mobilization in Washington DC. Leaders of the march will be talking to the White House this week and are hopeful that the rally will jump start the campaign for reform.

The **"We March for America" rally in DC on March 21st** is gaining major momentum with tens of thousands of immigrants expected from all over the country. Irish immigrants from the Irish Centers/groups in Chicago, Philadelphia, Boston and New York are organizing to make sure that the Irish immigrant community is represented. ## **Detention & Deportation**

Recent removal statistics for Ireland indicate what we already suspected. The number of deportations of Irish immigrants continues to increase. The total number of immigrants deported to Ireland in FY2008 was 91 in FY2009 this increased to 118. The numbers listed in the category "criminal" remains static at 19. The number without criminal issues increased from 72 in 2008 to 99 in 2009.

CIIC member groups continue to visit detainees and are working hard to ensure that immigrant rights are protected when they are detained by ICE. Last month CIIC Detention Rights Working Group members had a video conference with all the Irish Vice Consuls to highlight the current conditions and problems and to develop strategies to improve the situation for Irish immigrants.

We are also participating in a national training by the Detention Watch Network that will help members to understand the complexities of the detention system and learn more about how we can get justice and fair treatment for immigrants who are detained by ICE.

## **Irish Citizens Refused Social Welfare**

The CIIC has long been concerned that the current social welfare rules regarding residency are resulting in denial of social welfare benefits to immigrants who return from the United States.

Recent reports indicate that this, Habitual Residency Requirement or HRC is indeed resulting in the denial of benefits to returning Irish immigrants. The [Irish Times](#) and the [Irish Examiner](#) recently reported that the number of Irish citizens who were refused payments because they failed to satisfy residency requirements increased by almost 75% last year.

Currently applicants who have lived in the US (or anywhere outside the Common Travel Area) for the previous two years or more will have to show documentary evidence that Ireland is now their "center of interest." It is important to be aware that there is a presumption that the applicant is **not habitually resident** in Ireland at the time of making the application until the contrary is shown by him or her.

This is a major concern to Irish Centers here because their

clients who are undocumented here do not have the option of returning to the US if they have no means of support at home. While the increase in the refusal rate in 2009 may be the result of the Government's attempt to crack down on welfare fraud it is unconscionable to deny basic benefits to returning citizens. Thanks to [Crosscare Migrant Project](#) in Dublin who continue to monitor this issue.

## **The 2010 Census Begins**

Over the next few days households all over the US will receive their census forms in the mail. It is very important for everyone to complete and return these forms. The Justice Department issued welcome clarification recently on the issue of the confidentiality of census data. They said that no provision of the Patriot Act overrides the confidentiality law that protects census data. The legal information provided will not be shared with any other agency, at the local, state, or federal level.
